# EUREKA COUNTY FAIR

## BULL RIDING EVENT FORM

This is an invitation to bid to provide bulls for the Bull Riding event for the Eureka County Fair. Please use this invitation to submit your bid(s) and attach supplemental pages as necessary. Sealed bids will be received for furnishing services according to these instructions and specifications. To be considered, this invitation to bid form must be completed in its entirety and **must be received no later than 5:00pm local time on March 1, 2012**. The bids will be opened and read at the March 2012 Eureka County Fair Board Meeting. The decision to accept a bid will depend on the quality of the bid, not necessarily on the lowest bid price. If your bid is accepted, your bid constitutes a binding contract and includes the specifications of this invitation to bid.

1. This invitation to bid is to provide bulls for the Bull Riding event for the 2012 Eureka County Fair, to be held the second week in August.
2. The submitted bid must include transportation to and from the fairgrounds.
3. Bid by price per head of bulls.
4. Approximately 10-15 head of bulls requested (exact number to be specified as event approaches).
5. Bulls to be at fairgrounds Friday morning of the second week in August.
6. Bulls to be removed from the fairgrounds by Friday night.
7. All bulls must be sound and healthy.
8. Bidder must provide staff to load and unload bulls.
9. Bidder must provide staff to feed and water bulls during their time on the fairgrounds.
10. Hay will be provided (please specify hay requirements).
