This is an invitation to bid to provide horses for the Eureka County Fair Old West Saddle Bronc event. Please use this invitation to submit your bid(s) and attach supplemental pages as necessary. Sealed bids will be received for furnishing services according to these instructions and specifications. To be considered, this invitation to bid form must be completed in its entirety and **must be received no later than 5:00pm local time on March 1, 2012**. The bids will be opened and read at the March 2012 Eureka County Fair Board Meeting. The decision to accept a bid will depend on the quality of the bid, not necessarily on the lowest bid price. If your bid is accepted, your bid constitutes a binding contract and includes the specifications of this invitation to bid.

General Specifications

1. This invitation to bid is to provide horses for the Old West Saddle Bronc event for the 2012 Eureka County Fair, to be held the second week in August.
2. The submitted bid must include transportation to and from the fairgrounds.
3. Bid by price per head of horses.
4. Approximately 25 – 30 head of horses requested (exact number to be specified as event approaches).
5. Horses to be at fairgrounds late Friday afternoon of the second week in August.
6. Horses to be removed from the fairgrounds by the following Sunday morning.
7. All horses must be sound and healthy.
8. Bidder must provide staff to load and unload horses
9. ECF will assign pens for horses.
10. Bidder must provide staff to feed and water cattle during their time on the fairgrounds.
11. Hay will be provided (please specify hay requirements).
