# EUREKA COUNTY FAIR

## **ROUGH STOCK VENDOR BID FORM (Team Branding/Cutting/Rein Cow Horse)**

This is an invitation to bid to provide cattle for the Eureka County Fair Team Branding event. Please use this invitation to submit your bid(s) and attach supplemental pages as necessary. Sealed bids will be received for furnishing services according to these instructions and specifications. To be considered, this invitation to bid form must be completed in its entirety and **must be received no later than 5:00pm local time on March 1, 2012**. The bids will be opened and read at the March 2012 Eureka County Fair Board Meeting. The decision to accept a bid will depend on the quality of the bid, not necessarily on the lowest bid price. If your bid is accepted, your bid constitutes a binding contract and includes the specifications of this invitation to bid.

### General Specifications

1. This invitation to bid is to provide cattle for the Team Branding, cutting and Rein Cow Horse event for the 2012 Eureka County Fair, to be held the second week in August. (Aug 9-12, 2012)
2. The submitted bid must include transportation to and from the fairgrounds.
3. Bid by price per head of cattle.
4. Approximately 280 head of cattle requested (exact number to be specified as event approaches).
5. Only steers and heifers with no horns, or dehorned.
6. Weights to be in the 500 – 700 pound range.
7. Cattle will be used twice. (2 times)
8. Cattle to be at fairgrounds Wednesday evening of the second week in August.
9. Cattle to be removed from the fairgrounds by the following Sunday morning.
10. All cattle must be sound and healthy.
11. Bidder must provide staff to load and unload cattle.
12. Bidder must provide staff to feed and water cattle during their time on the fairgrounds.
13. Hay will be provided (please specify hay requirements).
