COOK SHACK BID FORM

This is an invitation to bid on the Eureka County Fair food services. Please use this invitation to submit your bid(s) and attach supplemental pages as necessary. Sealed bids will be received for furnishing services according to these instructions and specifications. To be considered, this invitation to bid form must be completed in its entirety and **must be received no later than 5:00pm local time on March 1, 2012**. The bids will be opened and read at the March 2012 Eureka County Fair Board Meeting. The decision to accept a bid will depend on the quality of the bid, not necessarily on the lowest bid price. If your bid is accepted, your bid constitutes a binding contract and includes the specifications of this invitation to bid.

General Specifications

1. This invitation to bid is to provide food services for the 2012 Eureka County Fair to be held the second week in August.
2. Must offer a wide selection of prices and variety of foods. Please include an example of your menu with suggested prices.
3. You are responsible for set up and take down at the beginning and end of shifts.
4. Please specify types of drinks being served (*No alcoholic beverages*)
5. Vendor must hold in good standing the required licensing and permits.
6. You are responsible to bus the area during shift and after shift. This includes wiping down tables.
7. The submitted bid must be inclusive of all cost, and no additional reimbursement will be allowed for travel or other expenses.
8. Failure to perform allows the Fair Board to hire a replacement with the original contract holder responsible for any additional costs between the original contract and the cost incurred due to failure of performance.
9. There will be a \$200.00 fee for the Cook Shack for the week.
