# EUREKA COUNTY FAIR

## ROUGH STOCK VENDOR BID FORM (YOUTH ROUGHSTOCK)

This is an invitation to bid to provide sheep, calves and steers for the Mutton Bustin, Calf Riding, and steer Riding Youth Roughstock events for the Eureka County Fair Youth Roughstock events. Please use this invitation to submit your bid(s) and attach supplemental pages as necessary. Sealed bids will be received for furnishing services according to these instructions and specifications. To be considered, this invitation to bid form must be completed in its entirety and **must be received no later than 5:00pm local time on March 1, 2012**. The bids will be opened and read at the March 2012 Eureka County Fair Board Meeting. The decision to accept a bid will depend on the quality of the bid, not necessarily on the lowest bid price. If your bid is accepted, your bid constitutes a binding contract and includes the specifications of this invitation to bid.

### GENERAL SPECIFICATIONS

1. This invitation to bid is to provide sheep, calves and steers for the Mutton Bustin, Calf Riding, and Steer Riding for Youth Roughstock events for the 2012 Eureka County Fair, to be held the second week in August.
2. The submitted bid must include transportation to and from the fairgrounds.
3. Bid by price per head.
4. Approximately 30 head of livestock requested (exact number to be specified as event approaches).
5. Sheep must have a minimum of 2 inch wool growth.
6. Calves must have a weight of 200 – 300 pounds.
7. Steers, or large calves, must have a weight of 300 – 600 pounds.
8. Livestock to be at fairgrounds Friday afternoon of the second week in August.
9. Livestock to be removed from the fairgrounds by the following Saturday morning.
10. All livestock must be sound and healthy.
11. Bidder must provide staff to load and unload livestock.
12. Bidder must provide staff to feed and water livestock during their time on the fairgrounds.
13. Hay will be provided (please specify hay requirements).

Bids are requested based on the instructions and General Specifications described above.
